That's not a good starting point. Also do not attempt any investigations with the premise of going in to get yourself scared or for the " Fear Factor" of it. That's pretty much an open invitation for trouble.

If you simply become quiet, and visualize a white light of peace and love covering your entire body, and then ask those you love who have passed to surround you in a shield of protection. And also claim the area of light which surrounds you and claim it as a protected area. Do not allow anything to enter without your permission, which you do not give.
